


Introduction

The Public Procurement and Disposal of Assets Authority (PPDA) is responsible for regulation, monitoring and oversight of public procurement and disposal of public assets in Malawi.





Principles of Public Procurement and Disposal of Assets



OPEN CONTRACTING

- The Open Contracting Initiative aims to provide as much procurement information as legally allowed to stakeholders.
- The rationale behind this initiative is to enhance transparency.
- It is generally accepted that fraud, corruption and any form of misconduct is reduced in environments that are open and transparent

Disclosure of Information








PDEs are required to disclose all the information which may materially affect the implementation of the procurement or disposal process (s. 57 (2) PPD Act). Interested parties include Non-Governmental Organisations, Civil Society Organisations, development partners, and the general public. PPDA is working in conjunction with other stakeholders including CoSTI -the Infrastructure Transparency Initiative to promote transparency in the construction sector. 
