DEFINITION

- Corruption is the abuse of public office for private gain. World Bank (1997)
- Conflict of Interest "A situation where personal or business interests of a party could adversely affect the outcome of a procurement transaction."
- A fraudulent practice is any act or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain a financial or other benefit or to avoid an obligation.
- **Corrupt practice** is the offering, giving, receiving or soliciting, directly or indirectly, anything of value to influence improperly the actions of another party."



DEFINITION

- Fraudulent practice is any act or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain a financial or other benefit or to avoid an obligation.
- **Collusive practice** is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party.



BACKGROUND

- **Financial Administration Regulations**, 1979 LI 1234) Part XII, Section 651 'Public Supplies and Equipment. (Public Supplies and Equipment by MOF)
- World Bank studies on public procurement in Ghana: Country Procurement Assessment Reports [CPAR] of 1985, 1986, Gosta Westring's report of 1997, and Country Portfolio Performance Review [CPPR] of 1998.
- 1996 : Public Financial Management Reform Programme (PUFMARP).
- 1999: **Public Procurement Oversight Group (PPOG)** was established by Government of Ghana
- The Public Procurement Act, 2003 (Act 663) was passed into law
- Establishment of the **Public Procurement Authority** in 2004
- Amendment of Act in 2016 with Act 914
- Public Procurement Regulation, 2022. (L.I. 2466)

- Standard Tender Documents and Standard Request for Proposals

Issues regulations in consultation with the PPA

INSTITUTIONAL FRAMEWORK

Public Procurement Authority

- Sets public procurement policy
- Monitors compliance by procurement entities
- Issues standard tendering documents/standard request for proposals
- Suspends suppliers and manages tender appeals
- Coordinates capacity building and professionalism in public procurement
- Manages and disseminate procurement information
- Develop and manage Electronic Procurement System

Tender Review Committees

- Responsible for approving procurement activities above the threshold of the Entity Tender Committees
- Include Central and Regional Tender Review Committees with differing levels of authority

Oversight Bodies

- · Monitor and audit public procurement
- investigate and prosecute breaches of Act 663 as amended

Procurement Entities

Head of Entity

- Awards low value contracts
- Chairs Entity Tender Committee

Tender Committees

- Approves procurement plans and invitation documents
- Awards contracts within its threshold/authority or ensures referral to the appropriate Tender Review Committee

Tender Evaluation Panel

 Ad-hoc committees which conduct evaluations and prepare evaluation reports

Procurement Unit

- Permanent unit staffed by procurement professionals
- Manages all procurement activities

The Private Sector

- Prepare tenders, quotations and proposals as tenderers
- Implement contracts as providers
- Includes providers of goods, works and services



PROCUREMENT PROCEDURES

- Mandatory Annual Procurement Plan (APP) (section 21)
- Mandatory Supplier Registration
- Eligibility and qualification criteria (section 22)
- Proper written records (section 26-28)
- Public publication for transparency (APP, Invitation to Tenders, Tender opening Records, Contract Details)
- Tendering Procedures
- Use of Framework contracting
- Complaints and Administrative Review (sections 78-82, Part Seven)
- Disposal of Items (sections 83-84, Part Eight)



SPECIFIC TOOLS

- Standard Tender Documents (with General Conditions of Contract)
- Average Price Database
- Unit Infrastructure Cost Estimator
- Ghana Electronic Procurement System (GHANEPS
- Right to Information Act



SANCTIONS

- Rejection of tenders, proposal, offer or quotation (Sec 32, Act 663)
- Fine not exceeding 2,500 penalty units or imprisonment for a term not exceeding 5 years or both (Sec 92, 93)
- Debarment
- Prosecution



INVESTIGATION & PROSECUTION

- Ghana Audit Service
- Public Procurement Authority
- Commission on Human Rights and Administrative Justice (CHRAJ)
- Economic and Organized Crime Office (EOCO)
- Office of the Special Prosecutor (OSP)
- Attorney General



CHALLENGES

- Low Pay
- Culture
- Interference of political/traditional/religious actors
- Delays in availability of procurement data
- Rise in non-competitive methods
- Inconsistency in prices/amounts for similar goods, services and projects
- Non-effectiveness of a lot of the Entity Tender Committees





- Former Electoral Commissioner of Ghana Procurement breaches
 - The use of Single source without PPA approval
 - No documentary evidence leading to award of contract
 - Unilaterally awarding contracts beyond her threshold without approvals from ETC or CTRC
- GRA/SML audit by KPMG
 - Proceeding with Single Source after rejection from PPA via another route
 - No parliamentary approval for a multi-year contract
 - No evidence of approval from GRA board
 - Improper pricing model for such services



RECOMMENDATION

- Independent Public Procurement regulator
- Increase the number of PPA Offices
- Increase the enforcement of Electronic Procurement System
- Certification of Procurement Officers
- Strengthen, monitor and build capacity of the ETC members
- Shorten the prosecution process and time
